Please refer to this office letter of even no. dated 22.11.2019 enclosing therewith Ministry of CA,F&PD, GOI letter dated 13.11.2019 regarding revision of Storage Charges payable by FCI to CWC for the year 2017-18 @ Rs 5.21 per bag of 50 Kg per month w.e.f 1st April 2017.

Various references were received from field offices as to whether storage charges payable to CWC for the year 2017-18 are applicable to SWC godowns where DOS has not yet been implemented, in view of the Audit objections. Accordingly, this office had sought clarification from Ministry on applicability of CWC rates for releasing Storage Charges to SWC for depots where DOS could not be implemented so far

Ministry of CA,F&PD, GOI vide D.O. letter no. 6-4/2019-SG-I(Part-I) dated 21.09.2020 informed that CWC has been advised to ensure complete implementation of DOS in all CWC and SWC godowns before 31st December, 2020, positively.

Considering the decision of the Ministry to allow time till 31.12.2020 for implementation of DOS, the matter has been examined in consultation with finance and accordingly, it is advised not to withhold the Storage Charges payable to CWC/SWC as approved by Ministry till the year 2018-19 on account of non-implementation of DOS.

Kindly refer to FCI's DO No. E.4 (20)/Stg.VII/Vol.VI/Part, dated 28/07/2020 on the subject mentioned above and to say that following decisions have been taken on the issues raised by FCI :-

(i) The issue of the Committee constituted under the Chairmanship of JS (Policy and FCI) to examine the issue pertaining to the claims of storage charges for the capacity utilized "over and above" the reserved capacity will be dealt with by As (Policy and FCI).

(ii) Implementation of DOS in all CWC/SWC godowns.

MD, CWC has been advised vide this Department's DO letter of even number dated 21.9.2020 (copy enclosed) to ensure complete implementation of DOS in all CWC and SWC godowns before 31<sup>st</sup> December, 2020, positively.

(iii) Fixation of storage charges for the year 2018-19 :-

Since, the matter of finalisation of storage charges payable by FCI to CWC for the year 2018-19 is under examination in IFD and may take some time, it has been decided that the storage charges payable by FCI to CWC for the year 2017-18, (i.e. Rs 5.21 per bag of 50 kg per month), finalised vide Department's order dated 13 November 2019, will be applicable for the year 2018-19, provisionally, till finalisation of the regular storage charges for the year 2018-19. Accordingly, necessary instructions have been issued to FCI, CWC and SWCs vide Department's letter of even number dated 21.9.2020 (copy enclosed).

(iv) Payment of Gunny bags :-

CWC's comments were sought in this matter which has informed that FCI is providing gunny bags for replacement of cut & torn gunnies and for collection of loose grains due to spillage in handling operations. Since, the gunny bags are not purchased by CWC and are supplied by FCI, the same have not been accounted as expenses in the books of accounts of CWC. Hence, the same has also not been included in the expenditure under head of Miscellaneous Charges or any other overheads. However, in the Department, the matter has been referred to PI Cell for further clarification. On receipt of any clarification in this regard, FCI will be intimated.
