Sir/Madam,

In supersession of above referred circular issued by HQrs. the rate of fumigation charges to be recovered from CWC for the issue of infested stocks to FCI and rate of initial fumigation charges to be paid by FCI to CWC for the dispatch of infested stock by FCI to CWC warehouses for up to 50 KG bags would be as follows:-

Further, the above initial fumigation charges would be applicable subject to the genuineness of the complaint is established i.e. written intimation through telephonic/ courier/ email would be sent by the CWC warehouse Manager to the consignee FCI Divisional Manager within 24 Hours about the nature and intensity of infestation and request him to get the stocks inspected by FCI QC staff within 2 days. If, no one from FCI inspects the stocks within 2 days of receipt of communication, the CWC warehouse Manager can go ahead with the fumigation immediately thereafter and maintain the records for future inspection by the Divisional Manager, which would be acceptable to FCI and accordingly CWC's claims for fumigation charge would be settled by the consignee FCI Divisional office"

For the SWC godowns hired by FCI, the above rates would also be applicable, in the cases which are at par in specifications, service and preservation of stocks with that of the CWC.

The revised rates would be applicable w.e.f 1st April, 2019.

This issues with the concurrence of Finance and approval of the Competent Authority.

 actual utilisation basis and storage charges payable
 to CWC by F.C.I.

Your kind attention is invited to para 4 of the above
 referred circular regarding storage charges payable to CWC
 for the storage capacity on actual utilisation basis and/or
 reserved capacity as notified from time to time.

2. The rates of storage charges payable to CWC as revised
 by Department of Food, Govt. of India w.e.f. 1.4.95 for 95 kg.
 bag have already been circulated vide this office letter No.
 E.12(3)/78-Stg.VII dated 23/26th October, 1998. *pn/c*

3. Now in accordance with the revised rates as applicable
 to CWC, the rates for the FCI stocks held by CWC for varying
 period and for the bags of foodgrains weighing less than
 95 kg. has been decided with the concurrence of finance and
 approval of competent authority.

4. For varying period the charges for bag packing of
 95 kg. are as under:-

The month for this purpose will mean a period of 30 days and the total storage charges calculated on per weight basis will not exceed the total charges payable per bag of 95 kg. for the full month. After the first week in storage the period will be reckoned as a calendar month.

The revised rates of storage charges as applicable to CWC could be extended to the State Warehousing godowns which are at par in specifications, service and preservation of stocks with that of the CWC. However, the Senior Regional Managers/ Zonal Managers would verify the above position through an inspecting committee before extending these rates to SWCs for similar services.
