- Sub.: (i) The rate of fumigation charges to be recovered from CWC for the issue of infested stocks to FCI.  
(ii) The rate of initial fumigation charges to be paid by FCI to CWC for the dispatch of infested stock by FCI to CWC warehouses.

Sir/Madam,


Kindly refer to this office circular issued vide letter of even no. 938-970 dated 01.05.2019 on the subject cited above. In this regard, references have been received from the field offices which are being clarified below:

- (a) In the aforesaid circular dated 01.05.2019, the provision of "Infestation due to delayed fumigation during storage due to non-availability of chemicals" may be read as "Infestation during storage due to any reasons" and in that case Warehouse Manager should arrange fumigation of infested stock immediately on detection of infested stocks & submit ATR on disinfection to FCI within a week time failing which recovery is to be effected at the rate mentioned in the circular dated 01.05.2019.  
(b) The rates mentioned in the above referred circular dated 01.05.2019 is also uniformly applicable in all the depots irrespective of Agency i.e. CWC/SWC/PEG/PWS.

All other terms and conditions of the circular dated 01.05.2019 will remain same.

This may be brought to the notice of all the field functionaries.
