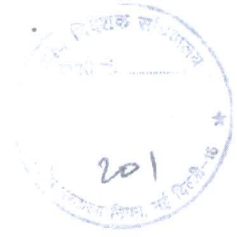

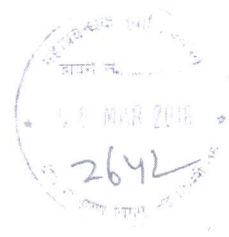

I am directed to refer to CWC's letter No. CWC/CD/II-FCI/Rate Revision/2015-16 dated 12.09.2017 on the subject mentioned above and to say that the Chief Advisor Cost, Ministry of Finance conveyed their recommendation vide their letter No.4(39)/CAC/2017 dated 22.12.2017 the storage charges payable by FCI to CWC for the year 2015-16. On the basis of recommendation, it has been decided to fix the storage charges payable by FCI to CWC @ Rs. 4.30 per bag of 50 kg per month w.e.f. 1st April 2015 for the year 2015-16 at the actual storage capacity.
