Sir,

Kindly refer to Department of Food & Public Distribution letter no. 16-02/2016-FC-II  
dated 18.11.2016 on the subject captioned above.

The comments on the issue pertain to Storage in respect of Assam are as under:  
The storage requirement of Assam was assessed in SLC dated 19.08.2016 and HLC dated  
09.11.2016. At present the storage capacity available in Assam is 3.91 LMT, 0.05 LMT is  
available for hiring and 1.90 LMT is under construction/consideration in PEG/Plan Scheme/  
Silos. The revenue districts wise details are enclosed herewith.

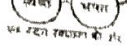


