in view of unprecedented procurement of foodgrains and in order to avoid storage of foodgrains in Kutcha plinths, FCI Hqrs. had issued circular increasing size of Wheat and Rice stacks so that capacity utilization of godown could also be increased (copy of circular dated 18.05.2012 enclosed).

In the light of above, General Manager, Tamil Nadu had requested RM, CWC, Tamil Nadu to accommodate stocks beyond 100% capacity but some of the Warehouse Manager of CWC (as listed in enclosed letter) are reluctant with the result that capacity utilization in some of CWC hired godowns has gone down in the range of 51% to 81%.

As Secretary (Food) has been reviewing this issue on regular basis, you are requested to intervene and suitably advise the concerned officers to cooperate and accommodate stocks even beyond 100% capacity to save grains from damages.

Subject: Stack size of Wheat & Rice for enhancing capacity utilization

Due to record high procurement of wheat which may go up to 350 lakh MT, it has been estimated that the stock level may reach an all time high level of 800 lakh MT as on 1.6.2012 out of which, the quantity of wheat stock is expected to be 481 lakh MT. As a result, a total quantity of 279.35 lakh MT wheat stock may have to be kept under CAP (Cover and Plinth) in the states of Punjab, Haryana, M.P. & Rajasthan out of which, 93 lakh MT wheat stock is expected to be stored under Katcha/Unscientific plinths.

In a situation like this, sincere efforts are required to utilize existing covered and scientific CAP storage capacity so that space can be made available in major wheat procuring States of Punjab, Haryana and M.P., and the storing of wheat on unscientific plinths may be avoided.

- To avoid storing of wheat on unscientific plinths, it is reiterated that the stack of 162 MT and 181 MT may be followed strictly in the case of rice and wheat respectively for all the covered godowns. By way of storing additional quantity of stocks in covered godowns by increasing the size of stack, equal quantity would be avoided to be stored on katcha/unscientific plinth.
- 4. The capacity utilization level may go up to 116% with 162 MT stack and the same may go up to 130% with 181 MT stack. Therefore, the capacity utilization of all the godowns may be ensured in the range of 110% to 120%.
- It is emphasized that no stocks should be stored in alleyways, gangways or on platforms only for the purpose of registering increased capacity utilization.
- 6. The existing instructions for issuing priority may be followed. However, in case, any stack of 162 MT or 181 MT shows little deterioration in quality, the same may be issued on priority with full justification recording appropriate reasons.
- 7. It is clarified that the unprecedented high stock level position and even more importantly the huge quantity of stocks stored under unscientific plinth/katcha has necessitated the above instructions to be issued with respect to the stack size and capacity utilization. These instructions may need to be reviewed in the future once this situation of high stock level is eased.
