### CIRCULAR

Sub: Amendment in the Model Agreement of Guarantee to be signed between FCI and CWC/SWCs/State Nodal Agencies for 6/9 years and 10 years of guarantee for DCP or non-DCP states.

Ref: 1. This office letter no. E.3 (28)/2008/HLC/Stg. IV dated 29.07.2013.  
2. This office letter of even no. dated 02.09.2013.

Reference is invited to above mentioned letters vide which Model Agreements of Guarantee to be signed between FCI and CWC/SWCs/State Nodal Agencies for 6/9 years and 10 years of guarantee for DCP and non-DCP states were circulated. Clause 1.9 of the agreement of guarantee for DCP States and clause 1.11 of the agreement of guarantee for non-DCP States deal with the issue of reservation of space/ commencement of guarantee period. The relevant text reads as "the reservation of space/guarantee period would commence from the first day of use of such godown after all arrangements are in place for storage of foodgrains after completion of the godown".

Through various representations, it has come to notice that clause 1.9 and clause 1.11 are not in conformity with the **Clause 31** of the MTF which states that "the reservation of space/guarantee period would commence from the date of taking over of the godown".


The matter was placed before HLC in its 37<sup>th</sup> meeting held on 07.11.2013 and it has been decided to amend **Clause 1.9** of the Model Agreement of Guarantee to be executed between FCI and CWC/SWCs/Nodal Agencies for 6/9 years and 10 years of guarantee circulated for DCP states as well as **Clause 1.11** of the Model Agreement of Guarantee to be executed between FCI and CWC/SWCs/Nodal Agencies for 6/9 years and 7/10 years for non-DCP states.

The amendment is as under :

"the reservation of space/guarantee period would commence from the date of taking over of the godown after all arrangements are in place for storage of foodgrains after completion of the godown."

The other contents of clause 1.9 and clause 1.11 will remain unchanged.

This issues with the approval of competent authority. It is requested to take necessary action accordingly.
