विषय: Clarification on payment of rent under PEG Scheme in DCP States.

महोदय,

Kindly refer to above mentioned letters on the cited subject. Attention is drawn to para 10 of PEG-2009 Scheme for DCP states regarding mode of payment which entailed that payment of storage rent for PEG godowns had to be made by state agencies and the same had to be claimed from DoF&PD on quarterly basis. The said modality of payment was subsequently changed by MoCAF&PD vide its letter dated 23.08.2013 directing FCI to pay the guarantee charges for PEG godowns in DCP states to state nodal agencies on monthly basis, exactly on the same pattern as is being done by FCI for non-DCP states. FCI has to submit quarterly figures of payments made towards guarantee charges of PEG godowns for each DCP state. DoF&PD would release funds to FCI quarterly from DCP budget head to recoup the expenses of FCI on this account. This change in modality of payment was circulated vide FCI Headquarters letter dated 02.09.2013.

Reference has been received from FCI RO Odisha, seeking clarification as to whether the storage rent of PEG godowns accrued prior to 23rd August 2013 shall be paid by State Govt. or FCI to CWC/SWC. In this regard it is clarified that Gol instructions dated 23.08.2013 is to be followed by FCI ROs with prospective effect and that too w.e.f. 01.10.2013 as earlier payment had to be made to State Govt. by Gol on quarterly basis. In case of payment of rent for godowns constructed by private investors, mechanism of payment circulated by this office circular dated 21.05.2013 (copy enclosed) may be referred. For the period from 23.08.2013 to 30.09.2013 (being a quarter end), the rent may be released only after getting clarification from Gol that rent has not been paid for this period, which is being sought from Gol and will be communicated to your office subsequently.

Further, as already instructed vide this office letter dated 11.05.2015, the statement of payment thus made to the State nodal agencies (in case of pvt. godowns) or CWC/SWC (in case of godowns constructed at their own land), should be submitted on quarterly basis to Budget and Cost division of FCI Headquarters to claim the same from DoF&PD.
