Sir,

References have been received from field offices for Seeking instructions in respect of payment of WPI hike to PEGs hired on lease with services.

In this regard, it is informed that in case, an increase in WPI makes the rent to increase and that also at compounding rate, then naturally, decrease in WPI must cause decrease in rent. **The very rationale of WPI provision in rent implies its movement and applicability both sides. Financial implications have to be and shall be applicable to both sides and to both parties.** WPI linking cannot be one way provision.

However, any decline in WPI shall never cause decline in the rate of rent below the original and initial guaranteed rate of rent.
