I am directed to refer to this Department's letter of even number dated 08.04.2010, 03.06.2010 and 11.01.2011 regarding scheme for construction of godowns through private entrepreneurs for DCP States.

2. In this regard, it is stated that the modality of payment(clause 10.2 in the scheme) made by FCI towards guarantee charges(lease/services) for the godowns to be constructed in the DCP States under the scheme is deemed to have been reduced from quarterly to monthly basis for State Nodal agencies, exactly on the same pattern as they are doing for Non-DCP States. Accordingly the revised clause 10.2 would read as under:-

"To pay guarantee charges (lease/Services) for PEG godowns in DCP States to State Nodal agencies on a monthly basis, exactly on the same pattern as is being done by FCI for Non-DCP States. FCI would submit quarterly figures of payment made towards guarantee charges of PEG godown for each DCP State. DoF&PD would release funds to FCI quarterly from DCP Budget head to recoup expenses of FCI on this account."

3. All other provisions of the Scheme and subsequent modifications will remain unchanged.
